The purpose of this MOU is to support the B.Voc. Program "Certificate Course in Library Automation" under UGC



The Parties intend to:


- 2.1 Pursue collaboration on fundamental, academic research
- 2.2 Provide mutual access to facilities for the purposes of fundamental, academic research related to library and information science.
- 2.3 Encourage collaboration and cooperation of projects involving researchers and personnel from the user communities associated with each Party.
- 2.4 The Visiting Party will comply with all of the requirements, rules and regulations of the Hosting Party, including safety, health, security, access and operational practices.
- 2.5 Provide training to the stake holders and aware them with advanced facilities.


3. **Confidentiality:** The parties agree that there is no intention to share any confidential or proprietary information in any collaboration under this MOU.
